

## **REACH Compliance Declaration Certificate**

We hereby certify that all goods produced by MEO Jewelry Co., Ltd., including jewelry made of 925 sterling silver, 9k gold, 10k gold, 14k gold, and 18k gold, are manufactured and supplied in full compliance with all of the requirements of European Union Regulation (EC) No. 1907/2006 regarding the Registration, Evaluation, Authorization, and Restriction of Chemicals (REACH) per the European Chemicals Agency (ECHA) 03/01/2021.

As determined by the REACH framework, MEO Jewelry Co., Ltd. is classified as a manufacturer of "articles" (per ECHA's guidelines) to our customers in the European Union (EU). MEO Jewelry Co., Ltd. is not a manufacturer of "preparations," "substances," or articles involved in the "intentional release of substances." Therefore, we do not anticipate that any registration, pre-registration, or authorization would be required for the articles that we manufacture and supply.

In accordance with REACH Article 33: "Duty to communicate information on substances in articles," we certify that none of the articles produced by MEO Jewelry Co., Ltd. contain any SVHCs (the Candidate List of Substances of Very High Concern for Authorization presently identified by ECHA, as of 03/01/2021) in quantities equaling or exceeding "a concentration of 0,1% weight by weight (w/w)," per REACH regulations.

In accordance with REACH Article 67: "A substance of its own, in a mixture or in an article, for which Annex XVII contains a restriction shall not be manufactured, placed on the market or used unless it complies with the conditions of that restriction," we certify that none of the articles produced by MEO Jewelry Co., Ltd. contain any Restricted Substances listed in REACH Annex XVII, per REACH Article 67 "conditions of restriction."

Because REACH legislation and other EU regulations are revised regularly, MEO Jewelry Co., Ltd. maintains a dedicated in-house team responsible for keeping all of our operations in compliance with the most recent directives, and we consequently keep this declaration updated to reflect these changes. The provisions of this declaration of REACH compliance supersede and replace the provisions of all other certificates previously posted relating to MEO Jewelry Co., Ltd.'s REACH compliance.
